Dear Stephanie

Last week, C.Y. Leung gave his final Policy Address as Chief Executive of Hong Kong.

Several local women's groups have been critical of the lack of childcare subsidies which featured in the Chief Executive's earlier Policy Addresses as well as the Government's omission to introduce MPF for homemakers.

At TWF, we sympathise with and support their concerns and would also have liked to see more focus on policies and programmes to address the challenges that women and girls continue to face in Hong Kong. On our wishlist, we had a commitment to review the 10 week statutory maternity leave policy with a view to potentially increasing this to the International Labour Organisation's prescribed minimum of 14 weeks, especially given this is already the position in the Mainland. We would also have liked to see a commitment by the government to encourage more girls and women to pursue STEM subjects and careers given Hong Kong's focus on technology and innovation as key pillars of economic growth.

At the same time, we were heartened by the Government's commitment to tackle three areas of discrimination in respect of which decisive action has been long overdue: first, the rights of foreign domestic helpers, secondly, support for people with disabilities, and thirdly, protection for sexual minorities.

According to Wednesday's Policy Address, the Labour Department plans to introduce an amendment bill this year to complement a newly promulgated code of practice for employment agencies aimed at offering better protection for the rights of domestic workers. If passed, the amendment will provide the legal basis for enforcing the code which is currently legally non-binding. The Chief Executive specifically mentioned Hong Kong's large population of some 350,000 foreign domestic helpers in his announcement, many of whom rely on employment agencies to find jobs. The department also plans to impose heavier penalties on employment agencies that overcharge jobseekers or operated without a licence.

The Government also announced a range of measures to support people with disabilities including setting up a standing advisory committee to review and follow up on the development of mental health services, injecting additional funding of HK\$100 million to create more employment opportunities for persons with disabilities and converting the pilot scheme on on-site pre-school rehabilitation services into a regular government subsidy programme.

Finally, we were quite honestly a bit surprised but nonetheless delighted to see included in the Chapter relating to Human Rights in the Government's Policy Agenda for 2017 an explicit reference to the LGBTQ community. According to the Policy Agenda, the Government plans to provide training and resources for personnel in specific fields to enhance their knowledge of and sensitivity towards sexual minorities, to draw up a charter on non-discrimination of sexual minorities for voluntary adoption by relevant organisations and individuals, to enhance public education and publicity to promote the message of non-discrimination, to review and reinforce support services and to conduct further studies on the experience of other jurisdictions in implementing anti-discrimination measures to provide a basis for future consultations.

At a time when the world is still reeling from Donald Trump's election and inauguration and many are concerned about the erosion of liberal norms and growing intolerance, the Hong Kong government's commitment to greater protections for these three marginalised communities is very welcome. We hope the underlying message that promoting a culture of diversity, inclusiveness and mutual respect is of critical importance is one that the new administration will strongly endorse and reinforce – both here and in the US!




