As the dust settles after last week's rejection by LegCo of the constitutional reform package, at TWF, we hope to see an enhanced focus going forward on incremental changes to the 1,200-member committee that picks the chief executive, giving more people a say in who gets to sit on the committee and changing its structure to make it more representative of Hong Kong society. These changes would not require the approval of the Central Government so this is an opportunity for Hong Kong's different factions to lay aside their differences and work together to forge a less elitist, more democratic structure.

The selection committee is currently far from representative. In 2012, for the last CE selection, the agriculture and fisheries industries which represent only 1 per cent of Hong Kong's economy and even less of its workforce, had 60 seats, far more than the 36 representing the finance industry. In gender terms, by TWF estimates, women made up around 160 of the 1,200 representatives. This is worse than LegCo where women currently hold just two out of 35 of the functional constituency seats and there are only eleven women altogether out of 70 members. There is a clear case for reviewing the arrangements for electing members of LegCo in 2016 and specifically, the functional constituencies which entrench the power of certain business sectors and contribute to the under-representation of women. This in itself would amount to a highly symbolic milestone of constitutional reform.

This is important because research from the Inter-Parliamentary Union and other studies show that parliaments and policy making bodies with more women pay greater attention to social welfare, education and environmental issues. Given the significance of these issues to Hong Kong, it is vital that women have a seat at the table when it comes to deciding the leaders and policies that will govern and shape Hong Kong's future.
