





International Day for the Elimination of Racial Discrimination



Dear TWF Friends,

Although the announcement of the phased approach to the relaxation of COVID-19 restrictions came as a relief to many, we know there is still a long road ahead to recovery. We hope you all are still prioritising your own mental well-being and engaging in daily activities that bring you calm.

On Monday, we commemorated the International Day for the Elimination of Racial Discrimination. COVID-19 has underscored just how deeply entrenched racial bias and discrimination is in Hong Kong. During the height of the fifth wave, there were many instances of ethnic minorities being wrongfully blamed for bringing COVID-19 to Hong Kong and shunned in public spaces. There were delays in translating pandemic-related policies and measures beyond Chinese and English causing confusion and heightening risk among minority communities that rely on information in other languages. Women and girls faced particular challenges from increases in forced marriages due to economic hardship brought on by the pandemic to increased abuse cases and illegal termination of employment for Migrant Domestic Workers.



#RapidTest Initiative Update

Our #RapidTest Initiative is in full swing! We are humbled by the generosity of the many organisations and individuals who are enabling us to provide underprivileged women and their families with needed rapid antigen tests at this difficult time. We have already distributed 16,000 test kits to our T.E.E.N. Programme Alumni, partner NGOs and Girls Go Tech Programme school partners, and are in preparation to distribute many more. Through supporting each other, particularly helping our most vulnerable, we will all emerge from this latest pandemic wave stronger and more connected- stay tuned for more updates.

Girls Go Tech: Cyber ABC Workshop

On March 11, GGT Programme participants took part in a workshop co-organised by State Street on Artificial Intelligence (AI), Blockchain & Crytocurrency and Cybersecurity. Speakers from State Street's Asia Pacific offices shared with participants on AI misconceptions and the uses of AI technology in a bank, the history and mechanism of blockchain and cryptocurrency, and how to better protect individuals from cyberattacks. The workshop was followed by a mingling session, in which State Street professionals from Hangzhou, Hong Kong and Singapore shared their job experience and advice with 23 student participants. 
Parent Workshop: Caring for Carers




Boardroom Series: Peer Circles

GOVERNMENT SUBMISSION

Issues Concerning Families with Young Children and Newborns During COVID-19

Keeping in mind the Government's roadmap for the relaxation on overall COVID-19 restrictions, we submitted a letter on Tuesday urging the Government to prioritise a review of certain restrictions adversely impacting mothers-to-be and families with young children, namely:

- 1. Separation of children from their parents / guardians if the child tests positive for COVID-19 and the parent / guardian tests negative
- 2. The Hospital Authority's reinstated ban on allowing women to have a companion of choice in delivery

rooms

3. Lack of communication around protocol for mothers giving birth should she and / or her newborn contract COVID while in the hospital

Regardless of their COVID status, newborns should have access to their mother to ensure their long term health and well-being. All women – regardless of income level – should have the right to a safe, supported and positive birth experience by having a birth companion present. And all children should have the mental security that comes with having a parent / guardian present when having to go into isolation due to COVID-19.
